

# **Decision Explained**

# Medicine: lenalidomide (brand name: Revlimid®)

The Scottish Medicines Consortium (SMC) has assessed lenalidomide for the treatment of adults with previously treated follicular lymphoma (FL). It is used together with another medicine called rituximab. This document summarises the SMC decision and what it means for patients.

### What has SMC said?

After careful consideration, SMC has accepted lenalidomide for the treatment of adults with previously treated FL as described above.

This advice takes into account a confidential discount offered by the pharmaceutical company that improves the cost-effectiveness of lenalidomide.

# What does SMC's decision mean for patients?

If your healthcare professional thinks that lenalidomide for use as described above is the right medicine for you, you should be able to have the treatment on the NHS in Scotland.



### What is lenalidomide used for?

Lenalidomide is used to treat follicular lymphoma (FL) that is grade 1 to 3A. Grade 1 to 3A FL is a slow growing cancer that affects a group of white blood cells called B-lymphocytes. It causes them to behave abnormally and build up in the lymph nodes and other parts of the body. Lenalidomide is used to treat FL in adults who have previously received treatment for their FL. It is used together with another medicine called rituximab.

#### How does lenalidomide work?

Lenalidomide slows the development of FL by blocking the supply of blood to the tumour, blocking the growth of the tumour and by helping the body's natural defence system to fight the cancer.

## How does SMC make its decision?

SMC carefully considers every new medicine to make sure it benefits patients and is considered to be an acceptable use of the limited resources in NHSScotland.

To do this SMC considers the following:

- Evidence from the company about how well the medicine works compared with current treatments available in Scotland, in relation to how much they will cost to buy and administer.
- The potential impact of the medicine on patients and carers.
- Advice from healthcare professionals about any benefits of the new medicine compared to current treatment, along with how the new medicine is likely to be used.

When SMC assesses a medicine it takes account of the needs of all patients in NHSScotland, not just those who may be treated with the medicine under consideration.
